The mailing of a printed abstract and participant certificate is scheduled for **April 15, 2021.**

After reviewing the materials received by the conference organizing committee, an email will be sent to the author on the acceptance of materials and details for payment of expenses (preparation for printing and publication of abstracts, as well as for payment of postage costs). Upon receipt of a copy of the payment document by the organizing committee, the participant will be informed (by e-mail) of the terms and conditions of receipt of the printed version of the abstract and the certificate of the participant\*.

Conference materials will be published in the form of an abstract (in electronic and printed versions). Abstracts can be written in **Ukrainian, Russian, English, Slovak, Czech.**

**The cost of participation in the conference** for citizens of Ukraine is 200 UAH (\$ 10 for nationals). and includes mailing in pdf format of the conference proceedings and the certificate of the conference participant in electronic form. Additionally, the author can order a printed collection (+150 UAH / \$ 10.); assignment of DOI (+350 UAH / \$ 20) and / or certificate of participation in a scientific topic (300.00 UAH / \$ 20).

## REQUIREMENTS FOR THE PRESENTATION OF ABSTRACTS

- Abstracts are provided by email only. Up to five full A4 pages (297x210 mm), including figures, tables, references.
- The list of used literature is placed at the end of the text and drawn up according to the sample.

- Text links are placed in square brackets.
- Theses should be typed in a Microsoft Word text editor, Times New Roman headset, size: for the main text 14 pt, for the list of literary sources 12 pt), Line spacing - one and a half. Text fields: upper - 30 mm, lower - 25 mm, left - 30 mm, right - 20 mm.
- Type formulas and notation in MathType 6.0 Formula Editor or Microsoft Equation 3.0 as a separate object.

**Materials with deviations from the established requirements are not accepted for posting at the conference field of discussion and for further publication**
